The amount will be contingent upon individual needs as well as available funds. Loans are available to eligible students for Trade Schools and Undergraduate college. Your high School, or last college transcript, must show a 3.0 or better grade point average (GPA) for undergraduate study. Undergraduate students are required to maintain a minimum of 12 units per quarter or semester. A 2.5 GPA is acceptable for Trade School programs. PLEASE NOTE: School attendance and units carried must be confirmed each year. Official transcript verifying GPA is required each year for renewal of loans. Without the confirmation of attendance, loan repayment procedures will be implemented immediately.
